Complimentary Wi-Fi Terms of Use

Kimberley Sands Resort Cable Beach (**Kimberley Sands Resort**) is pleased to offer you complimentary access to the internet, via a wireless LAN connection (**Hotspot**), for the duration of your stay at Kimberley Sands Resort (the **Service**).

Accessing the Service

- Kimberley Sands Resort provides the Service subject to the following terms and conditions of use (Terms of Use). If you do not agree to these Terms of Use, you may not use the Service. Your use of the Service indicates your acceptance of these Terms of Use in their entirety.
- 2. By accepting these Terms of Use and using the Service, you acknowledge and agree that you are at least 18 years of age or, if you are younger than 18 years of age, that your parent or guardian has approved your use of the Service and agrees to these Terms of Use.

User obligations and restrictions

- 3. In connection with your use of the Service, you agree:
 - (a) that you will only access the Hotspot using the login details provided to you by Kimberley Sands Resort;
 - (b) that you will not give the login details to any other person without the prior consent of Kimberley Sands Resort;
 - (c) that you will only use the Service while you are a guest at Kimberley Sands Resort;
 - (d) that you will comply with all applicable laws, regulation and Kimberley Sands Resort's policies;
 - (e) that you will comply with these Terms of Use;
 - (f) that you will not use the Service in any manner:
 - (i) which is, or which is intended to be, abusive, offensive, threatening or defamatory; or
 - (ii) which is, or which promotes, racism, bigotry, hatred, violence or harassment towards, any person or groups of people:
 - (g) that you will not use the Service to conduct, or promote the conduct of, any criminal activity or enterprise;
 - that you will not infringe the intellectual property rights of any third party (including but not limited to file-sharing applications which promote illegal or unauthorised copying of a third party's copyright);
 - (i) that you will not use the Service to transmit spam, junk or other unsolicited mass emails or messages;
 - that you will not use the Service to unlawfully collect or harvest any information or data belonging to a third party;
 - (k) that you will not use the Service to transmit, store, publish or upload any electronic material which is known to cause, or which may cause, damage to or limit the functionality of any computer software, hardware or telecommunications equipment or surreptitiously intercept or access without authority any system, data or personal information.  - (I) that you have no legal right to the Service and that the Service is provided subject to the limitations, including (without limitation) as to technical matters, security and editorial control set out in these Terms of Use.
- 4. You will be logged out of the Hotspot without prior notice if any of the following occur:
 - (a) you breach any of these Terms of Use as determined by Kimberley Sands Resort in its absolute discretion;
 - (b) the wireless connection is lost, disconnected or becomes out of range for any reason;
 - (c) no activity is detected from your wireless enabled device for a period of time;
 - (d) you attempt to manipulate or bypass any limitations of or restrictions on the Hotspot;
 - (e) we are unable to determine the IP address of your device;
 - (f) Kimberley Sands Resort determines, in its absolute discretion, that it is necessary or appropriate to suspend or terminate the Hotspot connection, including for maintenance or to protect its business or Service users; or
 - (g) in any emergency.

Technical matters

- 5. Kimberley Sands Resort will provide the Service subject to the following:
 - (a) while Kimberley Sands Resort will endeavour to provide a reliable, stable and secure connection to the internet, it does not guarantee that access to the internet will be secure, continuous, accessible, fault-free, free from disruptions, viruses or other malware at any time;
 - (b) no guarantee of network speed is given;
 - (c) the Service is not suitable for supporting any use which requires continuous, fault-free network connectivity or uninterrupted data traffic flow;
 - (d) the Service may be interrupted, suspended or curtailed at any time, without prior notice to you, to carry out maintenance or repair work which Kimberley Sands Resort determines, in its absolute discretion is necessary or desirable;
 - Kimberley Sands Resort may, but is under no legal obligation to, attend to any service faults, malfunctions or other problems associated with the Service; and
 - (f) Kimberley Sands Resort does not provide technical support in connection with the Services.

Security

6. Kimberley Sands Resort cannot guarantee the security of the Service at any time.

- 7. You acknowledge and agree that there are significant security, privacy and confidentiality risks inherent in accessing or transmitting information through the internet. These risks include (without limitation) interception of transmission, loss of data, the introduction of viruses and other programmes that can damage your computer or electronic networks. You acknowledge and agree that your access to and use of the Service is at your own risk.
- 8. You are solely responsible for any information or data uploaded, downloaded or otherwise communicated via the Service and you are responsible for keeping all personal usernames, passwords and other security-based information secure and private at all times.

A waiver of a right, power or remedy must be in writing and signed by the party giving the waiver.
- 21. A provision of these Terms of Use that is illegal or unenforceable may be severed from these Terms of Use and the remaining provisions of these Terms of Use continue in force.
- 22. These Terms of Use are governed by the law of Western Australia and each party irrevocably and unconditionally submits to the non-exclusive jurisdiction of the courts of Western Australia.
